About INADR and ILSMT

International Academy of Dispute Resolution (INADR) was founded in 2002 and is the first organization that sponsored mediation tournaments where students were the mediators in an international competition. Since that time, INADR tournaments have been hosted in more than seventeen countries and have had participants and representatives from over fifty countries.

Every year, INADR organizes an **International Law School Mediation Tournament (ILSMT)**. The tournament typically takes place during the spring semester and features law school and graduate school participants from all over the world. In even years, the tournament is held at the Law School at Loyola University in Chicago, IL, and in odd years, it is held outside of the U.S. In 2019, the tournament was held in Athens, Greece; in 2021, in Tbilisi, Georgia (virtual tournament); in 2023, in Bologna, Italy.

The tournament provides law students with the opportunity to learn about various forms and techniques used in mediation, as well as the opportunity to practice their mediation skills in friendly competition with other students from around the world.

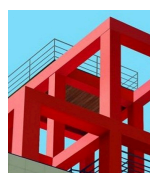

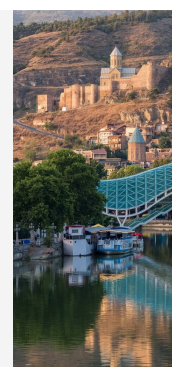
