About the educational components (courses) of the School of Health Sciences

### 1. Evaluation systems

- 1.1. The university operates a 100-point (100%) evaluation system.
- 1.2. The component is passed if 51 points (51%) are obtained.

- 1.4 A different method of allocating points during the assessment of components is determined by the academic council at the request of the school board.
- 1.5 Assessment forms may consist of one or more assessment components (written, oral, practical, etc.).
- 1.6 The requirement to pass the final exam is to obtain at least 50% of the maximum score. If the final exam consists of more than one assessment component, the student must receive at least 50% of the maximum score for each assessment component in order to pass the exam.

- 1.7 A student who did not get the minimum score for passing the final exam, but with a combination of assessment components (quiz, mid-term exam, presentation) scores 41 points and above, will be admitted to the additional exam.
- 1.8 A student who did not get the minimum score for passing the final exam, but with a combination of assessment components (quiz, mid-term exam, presentation) scores 41 points and above, will be admitted to the additional exam.
- 1.9 If a student is admitted to the supplementary examination according to clauses 7 or 8, he has the right to retake one or more components of the final examination. The last grade of each component will be used to form the final mark.
- 1.10 The additional exam is not allowed to be held earlier than 10 days after the main exam. Applicants wishing to take the exam should apply to the educational process administration service no later than 2 working days after the exam results are published. The day of publication of the exam results is considered the first day.
- 1.11 When evaluating a student in a component, the final score is rounded to the nearest whole number. Five tenths or five hundredths are rounded up.

### 2. Curative teaching

Curative teaching is a contact load, which, together with lectures and/or seminars, also includes practical studies in a clinical environment and is organized not by semester, but by days of curative practice. The duration of curative education is determined by the credits allocated to it, which can be from one to 30 credits. The duration of curation should not exceed one academic semester. The final curation exam is scheduled in the exam weeks (8th or 17th) determined by the university statute. Recovery of the final exam is allowed, while other forms of curation assessment are not subject to recovery.

### 2.1. Hourly distribution schedule of curative teaching:

There are 5 contact hours in one curation day consisting of lecture and/or seminar and practical training in a clinical setting. One credit of a course subject involves 25 hours, spread over three days of curation and a final exam.

# **2.2. 1.** When utilizing the curation system for teaching, the evaluation of students' achievement of learning outcomes is conducted through the following system:

### **2.2. 2.** Daily assessment (defined within a specific syllabus)

### 2.2.2.1. written (quiz)

By means of written quizzes, the student's assimilation of current theoretical material is assessed. The quiz is non-recoverable.

### 2.2.2.2. Daily assessment of clinical practice

The student's mentor/internship supervisor evaluates the student's activity and progress in the work placement component.

During clinical practice, there are the following requirements for the student:

- He/she came to the work practice on time and is prepared accordingly;
- Actively participates in the practical course, engages in discussions, and asks relevant questions.;
- Correctly performs tasks and instructions;
- Acquires clinical skills and subsequently demonstrates them in accordance with the topic of the work practice;
- is fair to colleagues, medical staff, patients and their relatives;

### 2.2. 4. Final exam

- Successful passing of the final exam is a necessary condition for passing the course.
- The final exam of the curation is held after the end of the curation, in the next exam week of the university (the 8th or 17th week of the semester).
- The final exam may include a written exam and/or an assessment of professional skills.

### Written component

• The written exam may consist of one or more evaluation methods (test with open or closed questions, topic; definition; task; formula, as well as its derivation; discussion of a case, etc.).

• In order to pass the exam, the student must score at least 50% of the maximum mark for the written component.

### Practical skills component

In the exam of practical skills, the student performs three or more tasks, each of which will be evaluated according to the following system:

- Specific checklists can be developed within a specific course to more accurately assess student performance.
- In order to pass the exam, the student must score at least 50% of the maximum mark for the clinical skills component.
